## Tree Risk Assessment Qualification

### TRAQ Course Information

This 3-day TRAQ course and exam is open to interested parties who meet the pre-requisites (see [Tree Risk Assessment Candidate Handbook](#)) and is **limited to 20 arborists** (first-come/first-served). The qualification consists of a 2-day educational course followed by a 1/2 day assessment that includes both a written and field component. It is required that you attend the course and successfully complete the assessment in order to receive this qualification.

**Registration closes on February 26, 2018 or when class is filled.** All payments are due by February 26, 2018. Cancellation/refund requests must be submitted by February 26, 2018. All applications will be reviewed for approval. Your registration will be finalized via email.
